RETURNING APPLICANTS, PLEASE DO THE FOLLOWING BY JULY 10, 2009:

- SUBMIT COMPLETED APPLICATION (ON BACK OF THIS FORM) INCLUDING \$150.00 APPLICATION FEE;
- SUBMIT A DRAWING OF THE PROPOSED PARKING LOT LAYOUT INCLUDING DRIVEWAY LOCATION(S); AND,
- SUBMIT A COPY OF YOUR HOMEOWNER'S INSURANCE WITH \$100,000/\$300,000 LIABILITY INSURANCE NAMING THE CHARTER TOWNSHIP OF GRAND BLANC AS ADDITIONAL INSURED.

ALL PARTICIPANTS, PLEASE BE AWARE OF THE FOLLOWING PARKING LOT REQUIREMENTS:

1. Rope off the road right-of-way, with the exception of the entrance and exit;
2. Adhere to parking lot drawings approved by Grand Blanc Township staff;
3. Cut grass prior to Buick Open;
4. No parking, persons, or signs shall be allowed in the road right-of-way;
5. Attendant on-duty during the entire duration of lot's existence;
6. Provide signage on lot indicating no cooler of any kind, no backpacks, no ice chests, no paper bags, no cameras, no cellular phones, no pagers, no firearms, etc., allowed on the golf course;
7. Sign to indicate the lot's closing time and a clear indication of the price of parking in the lot;
8. Sign must be no larger than eighteen (18) square feet per side, no taller than six (6) feet above grade and limited to one sign per street frontage;
9. Proof of liability insurance on the property of \$100,000/\$300,000 for the dates of the Buick Open;
10. Trash/refuse containers on-site;
11. 20 lb. ABC fire extinguisher on-site;
12. Breakdown of lot shall occur forty-eight (48) hours from the closing of event; and,
13. Clean up lot after Buick Open.
